# **NMCS Safeguarding Policy**

## **Policy statement**

For the purposes of this policy:

- A child is someone under the age of 18.
- A vulnerable adult is someone who may be unable to take care of themselves or unable to protect themselves against significant harm or exploitation.

Nenthead Mines Conservation Society (NMCS) acknowledges a duty of care to safeguard the welfare of children and vulnerable adults when engaged in activities under the auspices of NMCS.

NMCS aims to ensure its safeguarding practice reflects statutory responsibilities and government guidance.

NMCS aims to ensure that all children and vulnerable adults have a positive and enjoyable experience and are protected from abuse whilst engaging with NMCS in an environment that is appropriate to their needs.

NMCS Safeguarding Policy-related procedures will ensure that:

- Safeguarding arrangements and procedures are in operation that prioritise the safety and wellbeing of children and vulnerable adults engaged in NMCS activities.
- Everyone engaged in the delivery of NMCS activities for NMCS understands their roles and responsibilities in respect of safeguarding and is provided with resources to recognise, identify and respond to signs of abuse, neglect and other safeguarding concerns relating to children or vulnerable adults.
- Action is taken by NMCS in the event of incidents/concerns of abuse coming to light.
   Confidential, detailed and accurate records of all safeguarding concerns brought to the attention of NMCS are maintained and stored.

This policy and related procedures will be promoted to NMCS Members, Associates, and others operating under the direction of NMCS in the delivery of NMCS-related activities.

Failure to comply with the policy and procedures will be addressed promptly.
